## President's Message

The Fellows of the Pierre Fauchard Academy are still in a state of shock while remembering Richard A. Kozal, our Secretary General. He has left a mark in our hearts and lives, a man admired by all. He lived a full, productive life and was a credit to his Creator, his family, and to our great profession. We must close this chapter now and move on. This is what Richard would expect of us, and we shall!!!!

The first order of business at the recent Management Team Meeting near San Diego in Coronado, California, was to fill the position of Executive Director of the Academy. We have done so!

Judith Kozal is our new Executive Director, a unanimous decision of the Management Team and a logical choice.

Richard and Judith took over the job of managing the Academy 30 years ago. At that time, they were handed a shoe box of 3" x 5" cards listing the names of about 200 Fellows, active and retired. That was when they started to build the Academy and build they did!

The Academy will reach its 75th birthday in two years. Our Founders should be pleased with our accomplishments. It all began with attempts to have dental research papers created and published by dentists, not commercial entities. Then on to honoring dentists worldwide who have distinguished our profession above and beyond that which would be considered the "norm." Now, our PFA Foundation has distributed \$4.65 million in scholarships and grants over the past 12 years.

The Constitution, By-Laws, and Policy Manual Committee (Drs. Hedlund, Englander, Schafthauser, and PFA Attorney Jon Howe) has produced a new Policy Manual. Attorney Howe felt that this was necessary because our old Constitution, By-Laws, and Policy manuals were "outdated and needed simplification."

Due to some legal technicalities, which were unknown in the past, the PFA now has a 2009 contract for services rendered to the PFA Foundation.

The Awards Committee has bestowed the PFA Gold Medal, our highest award, to Dr. Eugene Sekiguchi of California, a former American Dental Association President and a multi-talented individual. Wait until you read his outstanding C.V! The Certificate of Merit is awarded to General Dr. Robert E. Brady, the outgoing Executive Director of the International College of Dentists.

Other honors include the Elmer S. Best Award for 2009, our highest award given to a non-resident American dentist; the Award goes to Dr. Zbigniew Janczuk of Poland. The Dental Trade & Industry Award goes to Gilles Pierson of the Acteon Company of France.

The 2010 Elmer S. Best Award will be presented to Dr. Jose Carlos Elgoyhen of Argentina.

Last year, 12 of the Latin American Sections met for the first time in Sao Paulo, Brazil. This year, the European Sections and guests were united for the first time. International Trustee Jose Dahan and Section Chair Frank Braun of Germany gathered 12 nations in Cologne, Germany. This venue was chosen because it was the biennial meeting of the largest dental meeting in the world, the International Dental Show with more than 100,000 attendees and 1,820 exhibitors from 57 countries. As you can see, an ideal setting for the European Sections to congregate! Some of our "surprises" were from Latvia, Romania, Hungary, Poland, the Republic of Georgia, Senegal, and the Congo. We hope to open some new Sections for the Academy.

As the Management Team convened at the Hotel Del Coronado, we stood in awe of this magnificent 121-year-old structure. It has been "modified" over the years, of course, but it is still the Crown Jewel of hotels. We wondered at the time, will the Pierre Fauchard Academy be able to stand the test of time and be as great an organization as this hotel is today. The answer is a resounding "YES" because of individuals like our PFA Fellows, each doing their part to make this world a better place.

# MANAGEMENT TEAM MEETING

7–10 May 2009

Hotel Del Coronado, San Diego, California

President Chuck Eller called the Meeting to order to establish a quorum with Immediate past President James Englander, President-elect Steve Hedlund, PFA Acting Secretary General Judy Kozal, Auditor Dan Jonker, Editor James Brophy, and President Chuck Eller in attendance. Vice President Hubert Ouvrard of Paris was excused. Editor Brophy gave the Invocation. And Dr. Eller held a moment of silence for our fallen Secretary General.

The PFA Constitution & By-Laws were reviewed led by Steve Hedlund. No substantial changes were noted, but a reworking of the Policy Manual was deemed necessary.

The Foundation contract was reviewed and finalized.

The Hall of Fame and its deposition were discussed. The plaques have been removed from the National Museum of Dentistry in Baltimore and have been returned to the Central Office. Former Hall of Fame Chairman Joseph Cappuccio's suggestion to relocate them at the new addition at the University of Maryland's Baltimore School of Dentistry was discussed awaiting further information.

The Awards for the Annual Meeting Awards Banquet presentations were discussed and agreed upon with the PFA Gold Medal being presented to Dr. Eugene Sekiguichi of California, a past ADA President. The Certificate of Merit will be conferred upon General Dr. Robert E. Brady, the outgoing Executive Director of the International College of Dentists. The 2009 Elmer S. Best Award is being presented to Dr. Zbigniew Janczuk of Poland. The Dental Trade & Industry Award has been selected to be presented to Gilles Pierson of the Acteon Company of France.

The 2010 Elmer S. Best Award nominee has been named as Dr. Jose Carlos Elgoyhen of Argentina.

Correspondence with the Canada PFA was reported. The President will continue the discussion, but as of that moment, no Canadian Trustee had been nominated for Board approval.

The Hawaii agenda was determined. Dress code for men was suggested as white slacks, blue blazer, Hawaiian shirts. Dress code for women was suggested as appropriate Hawaiian-style clothing.

The finalizing of the 2009 Budget was tweaked in this uncertain time of finances. Cost of securing *Dental Abstracts* has gone up and that needed to be factored into the budget. The PFA Web site costs for the coming year were proposed by our Web master Mark Stanley and discussed.

## **NEW BUSINESS**

**Central Office Report:** The past two months without Secretary General Richard Kozal's guidance has been a time of great sadness and anguish for us all. President Chuck Eller, President-elect Steve Hedlund, and Accountant Dan Jonker attended the Central Office in Mesquite, Nevada, to map out a plan for the continuation of the Central Office to ensure no interruption of the day-to-day Academy business. One hundred fifty-four new U.S. Fellows and 49 International Fellows have been processed with 45 more awaiting induction. The 2009 dues notices have been sent out. Twelve Distinguished Service Awards have been requested; 26 Senior Student Awards have been prepared and mailed.

The online Dues Payment Program has not been successful, and only some 10% of our 4,000 members have used it as opposed to using the more successful Lock Box collection system. Another program is being tried for next year.

**Richard Memorial:** This item was discussed with many suggestions forthcoming—all evidencing the fervor that everyone feels for our former Secretary General Richard Kozal. The ideas were all outstanding and funds were allocated for establishing the Richard A. Kozal Memorial Scholarship at the University of Las Vegas, Nevada, School of Dentistry. Other ideas were open and will be discussed further by the entire Board at the Hawaii Meeting.

**The Executive Board held nominations** for the coming 2009–2010 PFA Officers:

- Dr. Steve Hedlund of Iowa, as President-elect, will automatically become President;
- Dr. Chuck Eller of California, as 2008-2009 President, will automatically become the Immediate past President;
- Dr. Hubert Ouvrard of Paris, PFA Vice President, has been nominated for President-elect; and
- Dr. Joseph Harris of Michigan has been nominated for Vice President.

**Ernesto Acuna E. Latin America Trustee Report:** It is very important to consider our appearances at the following activities in South America.

The first would be the PFA Paraguay Section Meeting and Induction Ceremony in Asuncion, Paraguay, 17–18 July 2009 sponsored by Section Chair Dr. Emilio Kegler.

The next would be the Latin American Odontologic Seminar where the Mexico Section, Pacific Chapter, would be hosting their Induction Ceremony in Puerto Vallarta, Mexico on 3–5 September 2009.

And the 2nd Latin America Academic Meeting and PFA Induction Ceremony along with the FDI World Dental Congress in Salvador, Bahia, Brazil, on 2–5 September 2010.

The Management team then went into Executive Session at which time President Eller announced that they had unanimously accepted Judith Kozal as “our new Executive Director” with a three-year contract. “She will have two assistants—her close friend Louise and her son Michael,” Dr. Eller said.

# **WORLD'S LARGEST DENTAL MEETING**

**Cologne, Germany**

**27–28 March 2009**

Cologne (Koln), the largest city/port in North Rhine-Westphalia, Germany, with a population of over 1 million, was the host location for the Dental Exhibit, with the capacity to welcome a dental trade show that attracts over 100,000 participants from 57 countries viewing some 1,850 dental exhibits. International Trustee Jose Dahan and German Section Chair Frank Braun hosted a PFA reception with PFA International Officers President Chuck Eller, President-elect Steve Hedlund, and Vice President Hubert Ouvrard in Koln. Present were Belgium representative Dr. Christiaan Colpaert, Latvia representative Dr. Ilza Maldupa, Georgia representative Professor Dr. Vladimer Margvelashvili, Hungary representative Professor Dr. Nagy Katalin, Poland representative Professor Dr. Eugeniusz Spiechowicz, Romanian representative Professor Dr. Marian Vladimir Constantinescu, and Senegal representatives Dr. Rokhaya Diakhate-NDour and Professor Dr. Malik Sembene.

PFA Vice President Hubert Ouvrard discussed the role of the PFA Foundation in financially supporting research and education. Dr. Ouvrard had the delegates introduce themselves and discuss their professional activities.

Apologies for not being able to attend were received from Czech Professor Dr. J. Vlacek, Ireland's Dr. Ch. Lynch, Italy's Professor A. Pantarotto, Kenya's Professor P. Patel, The Netherlands' Dr. J. Van De Pol, Portugal's Dr. G. Alforado, and Swiss Chairman Rolland Soellner. The PFA event was held at the Allegro during the World's Dental Fair after a short address by German Section Chair Frank Braun. President Chuck Eller followed with a description of the PFA mission. President-elect Steve Hedlund discussed the PFA Foundation.

### ***Leave the Bottle Full for Others***

The following appeared in the University of Tennessee Alumni publication a few years ago. It expresses so well what the Foundation of the Pierre Fauchard Academy is all about. I have kept this in my files for years and would like to share it with you at this time.

Bruce Larson, in his book *Dare to Live*, retells the legend of Desert Pete. Travelers across a seldom-used trail in the Amargosa Desert would pass an old pump that offered the only hope of fresh drinking water along their journey. Wired to the pump was a baking powder can containing a handwritten note:

*This pump is all right as of June 1932. I put a new sucker washer into it and it ought to last five years. But the washer dries out and the pump has got to be primed. Under the white rock I buried a bottle of water out of the sun, the cork end up. There's enough water into to prime the pump, but not if you drink some first. Pour about one fourth and let her soak to wet the leather. Then pour in the rest medium fast and pump like crazy. You'll git water. The well has never run dry. Have faith. When you git watered up, fill the bottle and put it back like you found it for the next feller.*

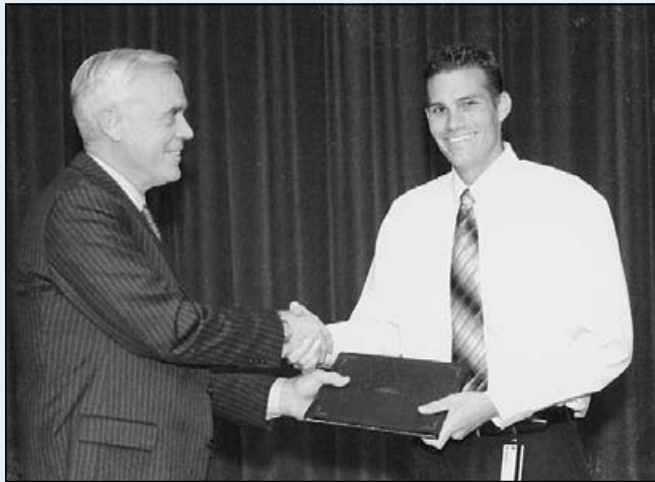

Their Section Project, the Connecticut Mission of Mercy (CTMOM) Project, received a Foundation Grant and had some 30 Fellows participate in their first year. Their grant for their second year has been successful as well. Over 50 Fellows participated in the last two days at the event held in New Haven last April. Their CTMOM Project has again been scheduled for 2010.

The Mission of Mercy Project has become a very important outreach program for Connecticut dentists. They have established a non-profit Foundation, the Foundation for Dental Outreach. Their goal is to become a repository of dental equipment for the New England area. This will allow other States to form their own similar programs without going to the expense of purchasing dental equipment. Their project has donated some \$1.5 million of free dental care to some 3,500 indigent patients.

Last year the Dean of the School of Dental Medicine was inducted into Fellowship. This year Dr. Mina Mina, the Chair of the Pediatric Dentistry Division, was inducted and gave a presentation on "Dental Stem Cells: A Promising Tool in Dentistry." Over 75 people attended their tenth year of a joint ICD/PFA Meeting.

### **Illinois**

Fellow Kathleen O'Loughlin of Medford, Massachusetts, has assumed the duties of ADA Executive Director at the Chicago ADA Headquarters. Dr. O'Loughlin will become the first female Executive Director in the ADA's 150-year history.

This marks the completion of an 11-month search for a new Executive Director. ADA President John Findley noted that Dr. O'Loughlin has 20 years' experience in private dental practice and public health dentistry with 10 years' experience in dental education and a decade in major leadership roles. She is a graduate of Tufts University with a DDS degree and has an MS degree in public health from Harvard University. She currently is a clinical assistant professor in the Tufts University Department of General Dentistry and is a University Trustee. She is also a Fellow in PFA, ICD, and ACD. Just as outstanding, she is a mother of four.
